Any and all costs associated with said contractors, sub-contractors, appraisers, umpires, and/or experts is separate from and in addition to the settlement fee owed to and is the responsibility of the Insured. Doug Wheeler (Kayco Roofing) will not hire or retain any contractors, sub-contractors, appraisers, umpires, or experts of any kind without the consent of the insured.

In the event this claim goes through the appraisal process, Insured has the option to either pay Appraiser and Umpire directly, or hire Kayco Roofing for claim repairs and Kayco Roofing will absorb all costs involved with the appraisal process. Including appraiser fees and Umpire fees.
